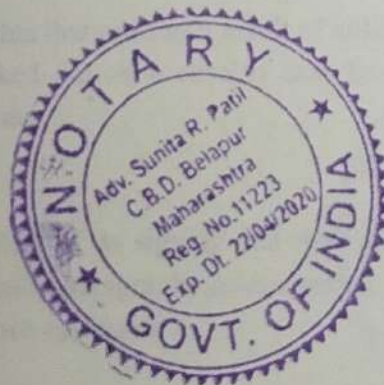


MEMORANDUM OF UNDERSTANDING

Areas and Modes of Collaboration:

MGM Institute's University Department of Nursing, Kamothe and MES' Pillai College of Education and Research, New Panvel (W) have agreed that in support of their mutual interest in the field of Education & Community service, both the institutions will:

1. Cooperate in the exchange of information through lectures and practicals relating to their activities in fields of mutual interests;
2. Conduct short certificate courses, as mutually agreed in writing between the parties;
3. Provide necessary help in the community service programs, as mutually agreed in writing between the parties
4. Provide awareness and interaction through conducting talks and workshops

Terms and Conditions:

1. Both institutions agree to supply work space, library and technical facilities as appropriate.
2. The consultancy and travel expenses related to the visits for lectures/sessions, talks and workshops will be reimbursed by the host institute on mutually agreed terms.
3. The MoU may be amended, renewed and terminated by mutual written agreement between the Heads of both the institutes.
4. Either institute shall have the right to terminate this MoU upon 60 days prior notice period to the other institute.

Confidentiality:

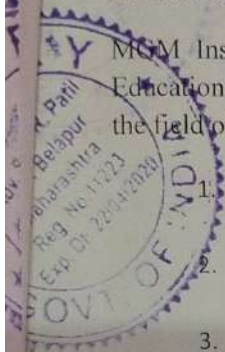
1. Both the institutes agree to hold in confidence any information or data designated by the institutes as being confidential and which is either obtained or created during the course of this MoU and will not disclose to the third party without the written consent of the other institute.
2. The above confidential clause does not include the information already available through public domain or information/data possessed by either institution before entering into this MoU.
3. The intellectual property rights that arise as a result of collaborative activity under the agreement will be worked out on a case to case basis with mutual written agreement of both the institutes.

Duration of MoU:

This agreement will take effect from the date of its signing and shall be valid for an unlimited period from the date mentioned in the opening paragraph, unless sooner terminated or modified by mutual written agreement between the two institutes.
